MCCMC DISASTER PREPAREDNESS AD HOC COMMITTEE

A. OBJECTIVE:

The Disaster Preparation Ad Hoc Committee was established to assess formal and informal preparedness activities and programs occurring in the member cities/towns. The Committee will work towards coordinating standards, implementing best practices, and support preparedness activities to maximize beneficial outcomes for all jurisdictions.

The Committee will meet quarterly and provide a written and verbal report after each meeting to the MCCMC members at the next regularly scheduled meeting.

B. GOALS:
