Excerpt from MCCMC By-Laws related to City Selection Committee, as amended March 2018:

#### ARTICLE V

#### Committees/Authority Assignments

Section 1. Standing Committees:

- a. <u>Legislative Committee</u>: The Legislative Committee shall consist of a Councilmember from each of the member cities, chosen by their respective City Councils, one city manager and one alternate city manager. Its duties shall be to review pending Federal and State legislation affecting cities and to take a position on the legislation consistent with a vote of the majority of the committee and the authority given the committee by MCCMC policies.
- b. <u>Executive Committee</u>: The Executive Committee shall consist of the President, Vice-President and the most immediate Past-President who is a member. It shall serve in an advisory capacity to the President to help plan and organize the activities of the COUNCIL.
- c. <u>Mayors Select Committee</u>: The Mayors Select Committee shall consist of the Mayor, or his/her designated representative from among each member's council, from each of the member cities and the Executive Committee of MCCMC. Its duties will be to form a consensus on and a recommended advocacy action for citywide and/or regional issues that directly and immediately affect all member cities and for which there is no other appropriate forum. The Mayors Select Committee shall also perform the functions of the City Selection Committee (relating to certain appointments and nominations) and under the powers vested by and pursuant to Cal. Gov't Code §50270 et seq. The Mayors Select Committee shall meet annually in April or at the first reasonably convenient time thereafter, and its Chair will be the President of MCCMC. Executive Committee members may be present but may not cast votes on City Selection Committee matters except when designated as described above. The President of MCCMC will report on the actions or recommendations of the Mayors Select Committee at the next regularly scheduled meeting of the COUNCIL, and shall call for a full vote of any recommended advocacy actions.

Re: Appointment to Metropolitan Transportation Commission as Marin County Representative

Dear President Colbert:

I am writing to express my interest in serving as Marin County's representative to the Metropolitan Transportation Commission (MTC). I am passionate about creating a multimodal transportation system in Marin and the North Bay that will serve our residents, local businesses, work force, and recreational users, whether they choose to travel by bicycle, transit, automobile, or on foot. During my tenure as an elected official, I have been actively involved in Marin's transportation planning and project delivery and have worked together with my city and town colleagues to create a transportation future that works for all of us.

I am a transit rider, a cyclist and walker, and a driver. I know we can use different travel modes to make different trips. As a commuter to San Francisco, I was a regular rider of GGT #4 bus and the Larkspur Ferry. As a Mill Valley parent, I helped launch Safe Routes to School in Mill Valley in 2000 and started the program at my children's elementary school, ultimately chairing the MV Safe Routes Task force for a decade. During that time, we increased student participation: starting from 5% to over 25% of students who walk, bike and carpool to school.

When Mill Valley began planning for the renovation of Miller Avenue in the early 2000's, I participated actively in the community planning for the project. When I was elected to the Mill Valley City Council in 2007, I was asked to co-chair the effort to bring the planning project to completion, and ultimately to construction in 2015. It was a complex project that took many hours of community meetings, planning and engineering - and creativity to design and fund the project. The County's Measure A Transportation Sales Tax provided much of the funding.

In shepherding the Miller Ave Streetscape project to completion with the community, we completely renovated Mill Valley's major two-mile traffic artery with a continuous bicycle lane, improved and accessible cross walks and transit stops, new signage, lighting, and street furniture. We created a street that works for all users of all ages. The project won three statewide awards, including the League of CA Cities 2019 award for "Best Local Street Project".

Moving into countywide transportation planning, as a City Councilmember and now Supervisor, I have served on the Board of Directors for the Transportation Authority of Marin (TAM) since 2008, as Chair 2014-2019, and again in 2022. During this time, TAM funding delivered many projects for improvements to local roads, bicycle facilities, EV charging stations, and expansion of the third lane on Hwy 101 in Novato, which will be completed within the next two years. As TAM Chair in 2018, I led the effort to renew Measure AA,

PG. 2 OF 2 Marin's Transportation Sales Tax, which passed with over 75% of the vote, guaranteeing reliable local transportation funding for the next 30 years.

My transportation experience also includes:

- Marin Transit District, Board of Directors 2009-present, Chair 2018 and 2022
- Sonoma Marin Area Rail Transit (SMART) Board of Directors, 2011-2018
- Hwy 37 Policy Committee, Member, inception-2018
- Golden Gate Bridge, Highway & Transportation District, incoming Board member, 2023

Other Relevant Experience:

- Bay Conservation and Development Commission (BCDC), current member Board of Directors representing Marin County Board of Supervisors
- Association of Bay Area Governments (ABAG) Executive Board 2021-2022, representing Marin County Board of Supervisors
- MCCMC Chair 2015-2016

There is much still to be done to complete a multimodal and carbon free transportation system for Marin. It will take focus and funding from MTC, along with local funding, to make this happen. Critical and yet to be completed components of our transportation future include:

- Completing our North-South and East-West bicycle facilities, as well as local bicycle networks to enable active travel for local trips.
- Electrifying our transportation system to reducing Marin's GHG's and carbon footprint.
- Providing reliable transit for our workforce, our students, and our expanding senior population.
- Continuing work to reduce congestion on our roads and highways for residents and our workforce.
- Planning for sea level rise for our road and highway network must be addressed. As a BCDC Commissioner, I am actively involved in regional planning for sea level rise and will be one of only two MTC Commissioners who will serve on both commissions and integrate the work of the two commissions.

I look forward to working with Marin's City and Town elected officials to make Marin's multimodal transportation future a reality and will work hard to make it happen. I would be honored to have MCCMC's nomination to represent Marin County on MTC. Thank you for your consideration.

Dear President Colbert:

I write to remind you that pursuant to the Metropolitan Transportation Commission's (MTC) enabling legislation at California Government Code Sec. 66500 *et seq.*, all MTC Commissioners are appointed to concurrent four-year terms. The current term of Marin County's representative on MTC, the Honorable Damon Connolly, is set to expire on February 9, 2023.

Therefore, I have been requested by the Commission to instruct the Council of Mayors and Councilmembers for the County of Marin to begin consideration of whether to nominate Mr. Connolly for reappointment, and to furnish the Marin County Board of Supervisors with the names of three (3) nominees from which the Board shall appoint a representative to represent Marin County and serve a four-year term that will commence on February 10, 2023.

MTC Commission members may be elected or appointed officials, or members of the general public. Pursuant to Government Code Section 66504: "Commissioners shall be selected for their special familiarity with the problems and issues in the field of transportation."

MTC Commissioners should expect to serve on one or more of the Commission's standing, special or advisory committees. Usually, the Commission and each committee meet one or two times a month in San Francisco. From time to time, the Commission may conduct public hearings in the MTC region, which MTC Commissioners may be requested to attend. A \$100 per diem (up to a maximum of \$500 per month), plus Commission-authorized travel expenses, are paid to members for attendance at meetings of their committees, the Commission, and public hearings held by the Commission.
