Excerpt from MCCMC By-Laws related to City Selection Committee, as amended March 2018:

#### **ARTICLE V**

#### Committees/Authority Assignments

#### Section 1. Standing Committees:

- a. <u>Legislative Committee</u>: The Legislative Committee shall consist of a Councilmember from each of the member cities, chosen by their respective City Councils, one city manager and one alternate city manager. Its duties shall be to review pending Federal and State legislation affecting cities and to take a position on the legislation consistent with a vote of the majority of the committee and the authority given the committee by MCCMC policies.
- b. <u>Executive Committee</u>: The Executive Committee shall consist of the President, Vice-President and the most immediate Past-President who is a member. It shall serve in an advisory capacity to the President to help plan and organize the activities of the COUNCIL.

c. Mayors Select Committee: The Mayors Select Committee shall consist of the Mayor, or his/her designated representative from among each member's council, from each of the member cities and the Executive Committee of MCCMC. Its duties will be to form a consensus on and a recommended advocacy action for citywide and/or regional issues that directly and immediately affect all member cities and for which there is no other appropriate forum. The Mayors Select Committee shall also perform the functions of the City Selection Committee (relating to certain appointments and nominations) and under the powers vested by and pursuant to Cal. Gov't Code §50270 et seq. The Mayors Select Committee shall meet annually in April or at the first reasonably convenient time thereafter, and its Chair will be the President of MCCMC. Executive Committee members may be present but may not cast votes on City Selection Committee matters except when designated as described above. The President of MCCMC will report on the actions or recommendations of the Mayors Select Committee at the next regularly scheduled meeting of the COUNCIL, and shall call for a full vote of any recommended advocacy actions.

Notification at least 48 hours prior to the meeting will enable the Authority to make reasonable accommodations to help ensure accessibility to this meeting.

Both of those letters were provided and available to the Committee and the 48 public. The applicants have the option to make a statement to the Committee. 49 50 He also explained that, this group would normally make their votes via ballot that would then 51 be submitted to Secretary Vaughn, who would share the results of the ballot. #### 2. Statements from candidates (optional)

#### Statement from Eli Hill, San Rafael:

Well, thank you. Honorable Mayors of the City Selection Committee. Thank you for the opportunity to provide brief remarks and consideration of my appointment to serve as the MCCMC alternate representative to the ABAG Executive Board. As indicated by written statement, I bring experience of having worked directly with public sector agencies throughout the state of California and across the bay area in a strategy and technology consulting capacity. More recently, I have had the privilege to serve my community as a member of the San Rafael Fire Commission, Planning Commission, and now the City Council. As we know, the policy is established by ABAG, have far reaching impacts to our communities, RHNA among them. I have conferred with Mayor Eklund on several occasions and believe we would team well to engage regional stakeholders and to drive outcomes for Marin that will serve our communities. I believe that it is essential that we assemble a team that will bring complimentary perspectives, which I believe we do. I appreciate your consideration and ask for your vote to be the MCCMC alternate representative to the ABAG Executive Board. Thank you.

#### Statement from Kevin Haroff, Larkspur:

I think most of my reasons for wanting to serve on this position, I'm very grateful for the opportunity to do that, but I've kind of outlined them in brief in my letter of interest. I didn't provide you with a resume, because I think in a variety of other capacities, you've seen that before and I don't want to bore you with it, but I would be very appreciative. I think I would do a good job and serve our community well.

As you all know, I'm the Mayor of the City of Larkspur, been on Larkspur City Council since 2013, and I'm also a former Planning Commissioner for the city. And throughout the time that I've been on the council, I've been ABAG's representative, Larkspur's is representative to ABAG and have worked with Pat and others to represent our interests in Marin in that context. Also, just note that, aside from the work that I've done for the city and within our community, from a political point of view, I'm a lawyer, as you all know, I have many years of experience, both in litigation and counseling clients on a variety of different environmental and land use matters with a particular focus on the California Environmental Quality Act.

And then finally, in terms of experience, I want to just highlight the fact that I do have already some extensive experience working with regional quasi-governmental agencies like ABAG, as I noted in my letter. I'm very pleased recently to have been elected to chair the MCE Clean Energy Board's executive committee, which kind of leads the policy determinations for MCE Clean Energy and requires working closely with elected representatives from cities throughout the north bay. I've listed them in the letter, a lot from Marin, but even more so from Contra Costa. And I'll just chime in with what Eli has said. We are under considerable pressure to accommodate ABAG's efforts to promote regional housing goals and that's a real challenge here in Larkspur because we have been identified essentially as a transportation hub because of the terminal point for the smart train, the Larkspur ferry and the intersection of Highway 101 and Sir Francis Drake Boulevard.

So we already are kind of have a bullseye on our back. We are not the only community in Marin. I think the prior discussion on RHNA highlights the fact that all of us in Marin are going to be a target of this effort. And

I think engagement with ABAG through Pat's efforts. And if you choose to have me be her backup, I'd be happy to be able to do that as well.

Following conclusion of the statements, MCCMC President Lucan stated that he would turn the discussion over to the City Selection Committee to determine how they wished to vote.

Mayor Eklund stated that she wished to move to nominate Eli Hill to serve as the MCCMC Alternate Representative to ABAG and if there was a second, then the group could continue the discussion on how to conduct the vote.

Mayor Colin stated that when she was MCCMC President, there was a similar situation, it was ballots and Rebecca ran around collecting them and there was a confidential nature to it. So I think if there is a way to direct chat to Rebecca, so everyone has to pay attention to that, then that would be in keeping with what the spirit is of the City Selection Committee. She proposed that as an option.

#### 3. Comments from MCCMC members and other members of the public

President Lucan asked if there were any questions or comments from MCCMC members. Mayor Eklund stated that Eli Hill was the only candidate that reached out to her to talk to her about the appointment and over the conversations, she believes that they would work really well together. The alternate and herself really need to work well together, and she believes that she and Councilmember Hill would be very good team for all Marin County. And that's why she has nominated Councilmember Hill, and will be voting for him for the alternate position. She further stated that this is not an easy position and it takes a lot of work. And Councilmember Hill has probably more time because he doesn't serve on any other regional bodies or large organizations. And she needs someone who is going to be there to help her to work with the other cities in Marin County to be able to get through this RHNA. ABAG is doing a lot, which needs to be communicated to the cities to help provide some technical assistance. She feels comfortable working with Councilmember Hill. He has the expertise, he was on the Planning Commission and the fact that he knows what other cities are doing because of his management skills, that is going to be tremendous, because we need to know and learn what other cities are doing as far as RHNA.

There no questions or comments from members of the public, and no public comments received via email. MCCMC President Lucan then confirmed that the Committee was comfortable with voting via Zoom chat. Upon seeing a majority response in the affirmative, he directed Committee members to find Secretary Vaughn's name on the list so that members are chatting their vote only to Secretary Vaughn, and asked them to send, via chat, their city and their vote. Secretary Vaughn will then tally the votes and provide a report.

#### 4. Mayors/Proxies discussion and vote

There was a motion and a second (Eklund/Colin) to appoint Eli Hill, San Rafael, to the remainder of a two-year term of Alternate MCCMC Representative to the ABAG Executive Board, which commenced July 1, 2020 and will expire June 30, 2022. The motion was unanimously approved by a vote through Zoom Chat sent to Secretary Vaughn, and archived for review upon request, of the Mayors of the cities/towns present.

The vote was 8 in favor of appointment of Eli Hill, 2 in favor of appointment of Kevin Haroff. (Tiburon absent).
