*Excerpt from MCCMC By-Laws related to City Selection Committee, as amended March 2018:*

**ARTICLE V**

Committees/Authority Assignments

Section 1. Standing Committees:

- a. Legislative Committee: The Legislative Committee shall consist of a Councilmember from each of the member cities, chosen by their respective City Councils, one city manager and one alternate city manager. Its duties shall be to review pending Federal and State legislation affecting cities and to take a position on the legislation consistent with a vote of the majority of the committee and the authority given the committee by MCCMC policies.
  - b. Executive Committee: The Executive Committee shall consist of the President, Vice-President and the most immediate Past-President who is a member. It shall serve in an advisory capacity to the President to help plan and organize the activities of the COUNCIL.
  - c. Mayors Select Committee: The Mayors Select Committee shall consist of the Mayor, or his/her designated representative from among each member's council, from each of the member cities and the Executive Committee of MCCMC. Its duties will be to form a consensus on and a recommended advocacy action for citywide and/or regional issues that directly and immediately affect all member cities and for which there is no other appropriate forum. The Mayors Select Committee shall also perform the functions of the **City Selection Committee** (relating to certain appointments and nominations) and under the powers vested by and pursuant to Cal. Gov't Code §50270 et seq. The Mayors Select Committee shall meet annually in April or at the first reasonably convenient time thereafter, and its Chair will be the President of MCCMC. Executive Committee members may be present but may not cast votes on City Selection Committee matters except when designated as described above. The President of MCCMC will report on the actions or recommendations of the Mayors Select Committee at the next regularly scheduled meeting of the COUNCIL, and shall call for a full vote of any recommended advocacy actions.

17 summary, because there's so much going on with ABAG and MTC that I feel it's better for  
18 people to get more information, then you can pick and choose what you want to focus on.  
19 But this year I'm serving on the Legislative Committee for ABAG. I'm also serving on the  
20 Regional Planning Committee. I'm also serving on the Housing Methodology Committee. I  
21 just, on Thursday night, got appointed to a brand new standing committee to deal with  
22 housing and this new organization that was created by AB1487, BAHFA, which is the Bay  
23 Area Housing Finance Authority. I think that we're really making a lot of effort to be more  
24 transparent. I was the one that suggested that we do a webinar on plan Bay Area and the  
25 RHNA, which is happening tomorrow. I am making other suggestions, which hopefully you'll  
26 see in the future. I made the suggestion that we actually ask ACD if we can get a delay in  
27 the RHNA. We did send a letter and then on Thursday night at the ABAG Executive Board  
28 Meeting, we talked about it and the president agreed, after we pushed, that he needs to  
29 actually talk to them, so that's what we're going to be doing. I would be honored to continue  
30 to serve as the Executive Board Member. As Joan said, we work well as a team. She's a  
31 smart attorney and I take a lot of her advice in the Legislative Committee for MCCMC and  
32 bring issues to that committee that ABAG is also dealing with too. I'm trying to bring more of  
33 the connections back to the respective committees of MCCMC. If anybody has any  
34 questions, you're more than welcome to ask."

I am writing to express my interest in being considered for appointment to the San Francisco Bay Restoration Authority. I currently am the Mayor of the City of Larkspur in Marin County and am Larkspur's representative to the Association of Bay Area Governments.

Larkspur shares San Francisco Bay shorelines with several Marin County jurisdictions, including unincorporated parts of the County, the City of San Rafael, and the Town of Corte Madera. Several of these shorelines include extensive and sensitive wetlands adjacent to the Bay and along Corte Madera Creek, one of the principal freshwater tributaries discharging into the Bay from Marin County watersheds.

In addition to my service to the community, I am an attorney with experience working on a variety of environmental issues relevant to the work of the Authority. On behalf of the Santa Clara Valley Water District, I was among those who helped develop a comprehensive estuarine protection strategy that was incorporated into the 1995 Water Quality Control Plan For San Francisco Bay/Sacramento-San Joaquin Delta Estuary. I also have assisted clients in managing wetlands-related issues around the Bay, and I have spoken and written on related subjects under Section 404 of the Clean Water Act on numerous occasions.

It would be an honor to contribute my experience and commitment to public service as a member of the Authority's Governing Board. Having represented both public and private interests in communities throughout the Bay Area, I am aware of the importance of making balanced funding decisions in the Region's collective interests. I have a demonstrated record of working successfully with representatives from communities outside my home jurisdiction, through service (among other things) on the governing boards of a number joint municipal powers authorities. As one example, I have since 2013 been on the Board and Executive and Technical oversight

### OVERVIEW

Kevin Haroff has represented businesses, individuals, and governmental entities in complex civil litigation and appeals, alternative dispute resolution, and regulatory matters for more than 35 years. In helping parties resolve difficult multi-party disputes, he has been praised for his ability to “keep adversaries at the table working toward a solution.”

- *Complex Civil and Appellate Litigation*

Kevin Haroff has represented clients in federal and state court litigation matters throughout the United States. Kevin was one of the lead attorneys involved in litigation challenging federal and state programs to manage the delivery water from the San Francisco Bay - Sacramento and San Joaquin River Delta (Bay Delta) and the California Central Valley Project, resulting in a landmark California Supreme Court decision validating the programs for future application.

Early in his career, Mr. Haroff obtained the complete dismissal of a multi-plaintiff personal injury and fear-of-cancer case involving alleged exposure to dioxin and other chemicals - the dismissal was upheld on appeal in all respects. More recently, he obtained a decision from the U.S. Ninth Circuit Court of Appeals affirming a district court's dismissal of an insurance subrogation case against a major U.S. manufacturing client - the U.S. Supreme Court denied certiorari review of the decision. Mr. Haroff also appeared before the Supreme Court in a case involving the scope of available injunctive remedies in lower federal courts.

Mr. Haroff has defended clients in a variety of matters brought under California's Safe Drinking Water and Toxic Enforcement Act (Proposition 65), involving claims of alleged unlawful exposures to lead, cadmium, mercury and other chemical substances (including second-hand smoke) in connection with a variety of different consumer products and exposure scenarios.

- *Environmental Law and Land Use*

Mr. Haroff has represented clients on a variety of matters under the federal Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA), the federal Clean Water Act, the Clean Air Act, the Endangered Species Act, and various other federal and state environmental laws. He has handled regulatory disputes involving the U.S. Environmental Protection Agency (EPA) and various EPA Regional Offices (Regions 5, 8, 9 and 10), the California Air Resources Board (CARB), the Bay Area and South Coast Air Quality Management Districts, the California State Water Resources Control Board and various regional water quality control boards, and the California Department of Toxic Substances Control.

Mr. Haroff is a recognized expert on land use issues under the National Environmental Policy Act (NEPA) and the California Environmental Quality Act (CEQA), and he has been involved with some of the largest residential and commercial development projects in California. He also represented a civilian airport authority in negotiations with the U.S. Department of Defense over the public benefit transfer of a former Naval air station on Guam.

- *Alternative Dispute Resolution*

Mr. Haroff has been involved in the mediation and arbitration of many different types of controversies. Kevin helped prosecute one of the first arbitration claims submitted to the Iran-U.S. Claims Tribunal in the 1980's. He also was involved in one of the first arbitration proceedings convened to allocate environmental response liability under California's hazardous waste control laws. He has had substantial roles in private party mediations over environmental liability under CERCLA, groundwater contamination issues, disputes over costs and pricing to dispose of municipal solid waste, arrangements for the provision of municipal water supplies, and insurance disputes.

# A Time for Change

Tiburon's new vice mayor talks about how challenges around diversity, technology, open space and pandemic closures are reshaping the town for the better.

Jon Welner is a busy guy. Not only is he the recently elected vice mayor of Tiburon, where he and his family have lived for 17 years, but he serves on numerous committees there, is president and on the board of the Osher Marin Jewish Community Center, is a leading environmental lawyer at the law firm Mintz, and is on the advisory board of the Environmental Law Section of the California Lawyers Association, among other pursuits. Welner talks about what 2021 holds for the town of Tiburon.

**In September of last year Tiburon police had a volatile encounter with Yema Khalif and Hawi Awash, the Black owners of Yema clothing store on Main Street, that led to the resignation of one police officer and the early retirement of the chief of police. In the aftermath a new diversity and inclusion committee was created. What can you tell me about that?**

What happened at Yema was terrible. I saw the video and I thought it was inappropriate behavior and it needed to be fixed. But I think we are responding to it wonderfully and I am very excited about this new diversity and inclusion committee. I insisted and am really happy that all the council members are participating in it along with the public. It's going to be a great learning exercise. We are going to take what we learn and everyone's ideas and make Tiburon a better place.

**Tell us about the Use of Technology Committee that you lead?**

It was the first thing I launched when I joined the council. Tiburon is one of the minority of communities that has posted audio instead of video of its council meetings. It seems like a small thing, but I think it really does matter to people in terms of feeling like government is transparent and feeling like they are participating. One of the effects of the pandemic has




been that all of our meetings are now on Zoom. I anticipate that after things return to normal, it will be a relatively easy matter to get the council to agree to video webcasting all of our meetings.

**What is currently being done at the 110-acre open space Martha property in the hills above Tiburon where a development of 42 large homes is being proposed?**

I've been working on a pro bono basis with the Tiburon Open Space Committee for well over a decade now trying to ensure that any development that occurs there is thoughtful and appropriate. We've been working and hoping to find a solution whereby some combination of the county and/or Tiburon could acquire the property and preserve it as open space. There are negotiations going on now between the Open Space Committee and the owner over creating an appraisal and trying to figure out if there is some way to broker a deal. I'm hopeful and optimistic that we'll

find a way to keep that as open space for the benefit of everyone.

**How are Tiburon's restaurants and retail doing during pandemic times and what is being done to help them?**

It's been really tough and we've lost some businesses, which is a source of great concern. We did have a very successful program that was really well liked to close off Main Street to cars in the summer months through October 1. It was a hopeful development that occurred. We are doing everything we can to help folks hang on until the vaccine becomes widely available and hopefully things come back to normal in the spring. The Caprice restaurant is under new ownership and has been using this time to rebuild and remodel; the new Michael Mina restaurant has been under construction all this time — so there are signs of great hope, new places that will open when things return to normal.

Dear Mayors:

This letter expresses my interest in serving on the SF Bay Conservation and Development Commission.

I am uniquely qualified to serve on the Commission especially given my experience working for the US Environmental Protection Agency (EPA) for 35 years, the US Army Corps of Engineers (Corps) for 7 years and in serving as a locally elected official for over 25 years.

My professional career started with the US Army Corps of Engineers in 1969. Shortly after Section 404 of the Clean Water Act was enacted, I was tasked with working on this new regulatory permitting program. That was the beginning of my regulatory involvement with the San Francisco Bay and Delta.

Throughout my professional career, I have worked on 'water' issues including ground water, drinking water, ocean dumping, NPDES permitting, wetland restoration, storm water, water quality planning and standards, wastewater treatment (grants, permitting, municipal sludge reuse, etc) and beneficial reuse of treated wastewater.

In 1977, I started working with EPA, Region 9 where I had the opportunity to work on a variety of environmental programs. I am especially proud of when I managed EPA Region 9's Oceans and Estuaries Program, I was responsible for nominating San Francisco Bay and Delta, Santa Monica Bay and others in CA and HI as regional estuaries as part of the Agency's National Estuary Program. This enabled the States and other local organizations to be eligible for federal and state grants and grow the local programs.

As Chief of EPA Region 9's NPDES permitting program, I worked with the Corps on their Section 404 permitting program, implemented Section 301(h) and (m) of the Clean Water Act. I was also involved with numerous efforts that ultimately resulted in dredged material being used for wetland restoration rather than disposal in SF Bay. Also, I worked with the State Water Resources Control Board and the 9 Regional Water Quality Control Boards on their permitting programs to ensure federal requirements were included.

As a Novato resident, I was appointed to the Restoration Advisory Board for Hamilton in 1991 by the Novato City Council. In that capacity, we worked with the



Corps, US Navy and other federal and state agencies on the cleanup and conversion of the Base to residential and office use. We also worked with the California Coastal Conservancy and the Corps on the largest wetland restoration project in North Bay at Hamilton/Bel Marin Keys – 2600 acres. As you can imagine, it was an exciting day when the outward levee was breached in 2014 that completed the first phase of the restoration. Hopefully, the Bel Marin Keys portion of the wetland restoration will be completely funded enabling the additional acreage to be converted to wetlands.

As a locally elected official, I helped Olive School successfully compete for a PG&E grant to develop educational materials along the Bay Trail as part of the Hamilton wetland restoration project. I also suggested and facilitated their involvement in collecting seeds and planting native wetland materials. I am also working to help complete the Bay Trail at Hamilton.

Several years ago, as a member of the ABAG Executive Board, I was asked to join the SF Estuary Implementation Committee. It is in that capacity that I helped facilitate how we were looking at the remake of Highway 37 by making it also a wetland restoration project.

Throughout my life, I have served on numerous boards, commissions, committees and workgroups that demonstrate my ability to work with staff, stakeholders and the public along with other elected officials at all levels.

I have held numerous leadership roles with the League of California Cities. As Vice President and President of the Mayors and Councilmembers Department for the League, I led the effort to establish the first set of bylaws for the Department. As Chair of the Environmental Quality Policy Committee for the League (twice), I led the committee composed of 50 locally elected and appointed officials on initiating legislation and taking positions on numerous federal and state bills. Many expressed their admiration of my dedication, working for consensus and willingness to stand up for what is right despite pressure otherwise.

In 2004-5, I served as President of the League of California Cities with a Board of over 50 elected and appointed officials. During my term as President, we were successful in the passage of Proposition 1A which prohibits the State from diverting local revenue. This measure passed in every County in the State. I also worked with Boards of other statewide organizations for Counties, Schools and Special Districts.

Specifically, she was instrumental in initiating and locating funding for two projects in San Diego County and Los Angeles County that involved working with the Regional Water Quality Control Boards to identify areas to streamline the oversight of owners/operators in remediating leaking underground storage tank sites. Because of the multiple jurisdictions involved in California's underground storage tanks program, there are opportunities for duplication and

overlap. These two separate projects initiated many quality improvement projects that have saved time, effort and reduced the cost of overseeing remediation efforts.

1987 to 1989 - **Director, Office of Ground Water  
U.S. Environmental Protection Agency**

Pat Eklund was responsible for integrating EPA programs and policies that impact ground water quality and management. This coordinated approach required a thorough knowledge and understanding of many federal statutes regulating water quality, drinking water, solid and hazardous wastes, superfund, pesticides and others. She was responsible for negotiating and administering ground water grants to State agencies for development and implementation of State ground water strategies; and, administering the wellhead protection and sole source aquifer demonstration program as mandated in the Safe Drinking Water Act.

1983 to 1987 - **Chief, Oceans and Estuaries Section  
U.S. Environmental Protection Agency**

Pat Eklund managed the ocean dumping program under the Marine Protection, Research Sanctuaries Act and the evaluation of waivers under Sections 301(h) and 301(m) of the Clean Water Act. This involved developing a plan directing the efforts of ten staff to designate ocean dumping sites and issue NPDES permits for selected publicly owned treatment facilities and pulp and paper facilities. She managed other marine programs that involved existing or potential environmental issues such as San Francisco Bay, Santa Monica Bay, Mexican/American ocean waters and Near Coastal Waters.

During a four month detail to EPA's Office in Washington D.C., Pat wrote the draft Agency policy on handling municipal sewage sludge. She initiated the concept of municipal sludge reuse and of regulating the disposal and reuse through the NPDES permitting program.

1977 to 1983 – **Environmental Protection Specialist (various positions)  
U.S. Environmental Protection Agency**

During these six years, Pat Eklund held various positions in the Agency including managing NEPA and CEQA compliance (e.g. EIS/EIR's) on the issuance of grants for construction of publicly owned sewage treatment facilities for the Cities of Los Angeles, Santa Cruz and the County Sanitation Districts of Los Angeles County; and working on the water quality planning and drinking water programs.

For three years (1980 – 1983), she worked with Mayors, City Council Members, County Supervisors and Directors of Public Works within the cities and counties of the Los Angeles Basin. Pat identified and closely monitored EPA, State and local activities with large EPA investment within the Los Angeles, Orange, San Bernardino, Riverside and Ventura Counties that have significant policy implications. She was also responsible for overseeing a consent decree between EPA versus the City of Los Angeles and the State of California to eliminate the sludge disposal in the Pacific Ocean by July 1, 1985.

1969 to 1977 - **U.S. Army Corps of Engineers** (various positions)

Pat Eklund held numerous positions during her eight years with the U.S. Army Corps of Engineers. Initially, she worked at the SF Bay-Delta Hydraulic Model located in Sausalito, CA where comprehensive studies were performed on pollution and water quality, sedimentation and shoaling, reclamation and flood control where she conducted tours for small and large groups ranging from elementary school children to highly skilled engineers. From 1974 to 1977, she directed the public information program for the Model and was instrumental in implementing public participation for the Corps' permitting program regulating discharges of dredge and fill material into waters of the United States pursuant to Section 404 of the Clean Water Act.

The Board raises funds for tuition assistance for families in need and for improving the childcare center services.

1994 to 2013 - **Restoration Advisory Board for Hamilton Army Airfield** - provided feedback on proposed approach and standards to cleanup the Base, buildings and infrastructure including an abandoned airfield. Ensured cleanup levels protected intended re-use of the area. Reviewed and commented on multiple environmental documents which required an understanding of the cleanup programs in CERCLA, RCRA and CWA.

She provided oversight of high risk incidents and ensured follow up actions were taken with the physician, nurses, patient, hospital staff, and legal staff.
