### ABAG Report to MCCMC<sup>1</sup> January 2023

#### **EXECUTIVE SUMMARY:**

- <u>Bay Area Housing Finance Authority</u>: MTC and ABAG collaborated to establish the Bay Area Housing Finance Authority which has decided to place a housing measure on the 2024 ballot. The intent is to offer a powerful new set of financing and policy tools to promote housing affordability to address the region's housing crisis.
- 2) <u>Bay Area Regional Energy Network (BayREN)</u>: This year, BayREN is celebrating 10 years of helping create sustainable communities across the Bay Area by promoting resource efficiency at the regional level, focusing on energy, water and greenhouse gas reduction. To date, BayREN has helped mitigate 156 tons of carbon, upgraded 60,695 housing units and provided \$55.4 million in incentives to help make the region more environmentally friendly.
- 3) Form-Based Codes Institute (FBCI) Form-Based Code Award: Marin County and Opticos Design have been awarded the FBCI Form-Based Code Award for achievement in the writing and implementation of a regional model of form-based zoning code. Earlier today, the authors of the code and planners presented their regional approach to zoning at a webinar hosted by Smart Growth America.
- 4) <u>ABAG Flood-Risk Maps</u>: The recent storms throughout the West have brought lots of attention to flood-risk. ABAG has online resources on flooding including a hazard map that shows 100- and 500-year floodplains as designated by FEMA, as well as potential floodplains currently protected by levees. (From January 2 through January 6, there was a big spike in ABAG website traffic (normally ~575 visits a day, up to as high as ~3,400 on 1/4), with the Resilience/Flood page being the top page on the site (by 4x over the homepage) from 12/1/2022 through 1/11/23.
- 5) <u>MTC Executive Director</u>: Therese W. McMillan Executive Director, MTC/ABAG is retiring effective January 30, 2023. A nation-wide recruitment was issued in late 2022 and in January 2023, both ABAG and MTC conducted interviews for the new Executive Director position. MTC will be conducting final interviews on January 30<sup>th</sup>.

**BAY AREA HOUSING FINANCE AUTHORITY (BAHFA):** BAHFA is a shared initiative of ABAG MTC, in partnership with cities and counties, to step up efforts to address the Bay Area's chronic housing affordability challenges. ABAG and MTC have committed to expanding the agencies' regional housing portfolio and BAHFA represents a key financial pillar of these efforts.

Established by AB 1487 (2019, Chiu) BAHFA is the first regional housing finance authority in the state and will offer a powerful new set of financing and policy tools to promote housing affordability. ABAG and MTC policymakers collaborated closely during the legislative process to establish BAHFA, including its unique joint governance structure that requires a double green-light process to obtain policy and programming approvals from both the ABAG Executive Board and the BAHFA Board (composed of the same board as MTC).

A part of the Bay Area's expanded regional housing portfolio toolbox, BAHFA will be developing a regional strategy for helping local governments tackle the housing crisis on a larger scale by transcending city and county boundaries. One of the key features of BAHFA is its ability to raise significant new funding for the "3 Ps" (Protection, Preservation, and Production) through a regional revenue ballot measure anticipated in 2024. The intent is to offer a powerful new set of financing and policy tools to promote housing affordability to address the region's housing crisis.

**BAY AREA REGIONAL ENERGY NETWORK (BAYREN)**: This year, BayREN is celebrating 10 years of helping create sustainable communities across the Bay Area by promoting resource efficiency at the regional level, focusing on energy, water and greenhouse gas reduction. To date, BayREN has helped mitigate 156 tons of carbon, upgraded 60,695 housing units and provided \$55.4 million in incentives to help make the region more environmentally friendly.

**Form-Based Codes Institute (FBCI) Form-Based Code Award:** The Form-Based Codes Institute (FBCI) at Smart Growth America announced that the 16th annual FBCI Form-Based Code Award was awarded to Marin County and Opticos Design for their creating a Toolkit of Objective Design and Development Standards to serve as an integrated catalog of standards calibrated to the Marin County environment, providing a variety of zoning tools based on a palette of eight zone districts to deliver context-sensitive design standards for multifamily and mixed-use residential development across Marin County's 520 square miles of diverse towns and cities.

## Highlighted Current Items From Past Meeting or Since Past MCCMC Meeting

# 1. Golden Gate Bridge District Awarded \$400M Federal Grant to Complete Seismic Retrofit

The Federal Highway Administration (FHWA) announced today that the Golden Gate Bridge, Highway and Transportation District (District) has been awarded a \$400M grant to complete the final phase of the Golden Gate Bridge seismic retrofit. The grant is provided through the FHWA's Bridge Investment Program, which received \$12.5 billion in funding from the Infrastructure Investment and Jobs Act of 2021.

"For more than eight decades, the Golden Gate Bridge has stood as a symbol of the innovative spirit of the Bay Area and our nation," Speaker Nancy Pelosi said. "The Federal Highway Administration's \$400 million investment will help ensure that this iconic landmark continues to safely and reliably serve our region for many years to come. As a proud Representative of San Francisco, it was my privilege to work alongside President Biden, Secretary Buttigieg and the entire Bay Area Delegation to ensure our region receives its fair share of the Infrastructure Law's once-in-a-generation investment in America's bridges."

"The Golden Gate Bridge is an international icon and key transportation link for the Bay Area that serves tens of millions of residents and visitors every year," said Denis Mulligan, District General Manager. "This vital funding allows us to finish strengthening the Bridge against disasters. Thanks to Speaker Pelosi, the Biden administration, and the entire Bay Area congressional delegation, the Golden Gate Bridge will be protected for generations to come."

The Golden Gate Bridge seismic retrofit will strengthen the Bridge against major earthquakes and disasters. Due to the scale of the project, the seismic retrofit has been broken up into four phases, three of which have already been completed. The final phase of the project, called Phase 3B, includes strengthening the main span of the Bridge, two side spans, both towers, the south tower pier, and the underside of the toll plaza. The construction budget is \$879 million, with the remaining funding expected to come from a combination of state grants and District capital reserves. Construction is expected to begin in late 2024 and finish in 2029.

The first three phases of the seismic retrofit were completed between 2002 and 2014. With the earlier phases of the retrofit complete, the Bridge can safely withstand an earthquake over 7.0 in magnitude, but it may experience damage that requires closure after a major seismic event. Completion of the final phase of the retrofit will further harden the Bridge against damage from an earthquake or other disasters.

Board of Directors Approves San Rafael Transit Center Replacement Project and Takes Action Relative to the EIR-December 16, 2022

The Board of Directors approved the San Rafael Transit Center Replacement Project (Project) and took the following actions relative to the Final Environmental Impact Report (EIR) for the Project:

- adopted the Final EIR;
- approved findings and approving a mitigation monitoring and reporting program;
- certified that the document meets all the requirements of the California
- Environmental Quality Act (CEQA); and then,

• approved the Project and selecting the Move Whistlestop Alternative as the preferred Project alternative.

Please see a summary of my comments:

Director Thier expressed support for the project and commended the team for their efforts. She said that the San Rafael Transit Center (SRTC) project is critical, and operations have outgrown the site. She encouraged a strong community design effort and continued collaboration between the District and City of San Rafael. She spoke about the SRTC becoming a landmark in the area, and offered her assistance.

### Update on the MCCMC Homeless Committee January 2023

#### Submitted By Chairs: Rachel Kertz - San Rafael Councilmember and Chance Cutrano - Fairfax Councilmember

The MCCMC Homeless Committee leads with the value that everyone should be treated with dignity. Although the MCCMC Homeless Committee has been on a pause, there is important work and discussions happening around the county to support the homeless. It is time to bring the Homeless Committee back as one of MCCMC's active committees to review current initiatives, learn best practices from neighboring counties and work together to support one another on addressing issues related to the unhoused.

Homelessness has been part of our jurisdictions for years. The past few years have brought the issue of homelessness to the forefront. As a county we have moved to the Housing First model to address homelessness, but we know this is not the only answer. We need to bring more stakeholders into the discussion and continue to address with urgency the needs of the homeless community.

#### **Objectives:**

- Reduce chronic homelessness in Marin County
- Reduce the total number of homeless individuals and families in Marin County
- Support implementation of appropriate countywide and regional solutions

#### Strategies:

- Provide a forum for discussing homelessness and solutions
- Expand the discussion of homelessness in Marin County by having Committee members regularly update their Council and City Management
- Support the Community Homeless Fund (CHF) which is supported by all jurisdictions and matched by the County through 2025
  - Delivers immediate, basic human needs, with urgency
  - Locally driven and supported all cities/towns participate
  - Entry to system navigation, employment, case management
  - Based in care and compassion, deliver dignity
  - Provides person to person relationship building

  - Contracts covering more than two-thirds of the fixed route service are set to expire at the end of June 2023.
  - Approved Plan to move forward with fixed route modifications to better align schedules with customer demand, specific recommendations will be on next meeting agenda
- Regional Transit Management Plan Update MTC consultant recommends creating a new committee at MTC, Regional Network Management Committee, to oversee coordination of interconnections between transit agencies.
  - Funding of new Committee and its staff is a significant issue

### **Committee Report 5e**

### Sonoma-Marin Area Rail Transit District

The MCCMC Representative to SMART, Gabe Paulson, Larkspur, has provided the following update regarding the SMART Board of Directors:

- On Jan 18th, the SMART Board authorized a contract to address the "last mile" problem at Sonoma Airport. The issue is that the distance between the Sonoma SMART Station and the airport is 1.2 miles, inconvenient for most. By using a microtransit service and "on demand software" similar to Uber/Lyft, SMART will attempt to both shuttle riders and pickup from residences and businesses, thereby supplemented bus route 62. We are eager watching this implementation with possible use in San Rafael and Larkspur.
- The rains caused minor damage and reduced services, for example Novato Creek flooding at Hwy 37-101; switch on Ygnacio Y is underwater, Hannah ranch road (Jan 14, affected passenger lines), Schellville. Crew quickly completed most repairs and is looking for ridership recovery in the better weather.
- 3. Next month is FebBREWary a promotion of the service and Sonoma-Marin craft beers with SMART service.
