Welcome and Introduction of Guests:

Mayor Al Boro welcomed everyone to San Rafael and introduced his fellow Councilmembers. The following staff members were introduced: Rod Gould, City Manager, Lydia Romero, Assistant City Manager, Carlene McCart, Director of Community Services, Andy Preston, Public Works Director, Jeanne Leoncini, City Clerk, and David Dodd, Library Director.

Approval of Minutes: March 23, 2005.

Moved and seconded to approve as submitted. Motion passed.

Committee Reports

a. <u>Legislative Committee</u> - Anne Solem stated that the Legislative Committee members will poll their city councils regarding the two health care bills being proposed (Nation's and Kuehl's) to see if there is sufficient interest in some kind of presentation at a future meeting. The Committee has expressed its support for restoring booking fees to cities and is asking each city/town to work individually to lobby Sacramento on its behalf.

She made reference to hand-outs which describe a menu of activities developed by the subcommittee working with the Marin County school districts. These are possible actions that councilmembers can take to support the restoration of state funding to schools guaranteed under Prop. 98. The schools are very enthusiastic about this joint effort, which will engender a long term relationship and community effort. She noted that, unless there is some objection, each city and school district will be listed on the "Marin Community United" letterhead.

Another MCCMC joint meeting with the school officials is being planned for this fall.

- b. Marin Telecommunications Agency Dan Hillmer, MTA Chair, indicated the committee conducted a community access needs assessment; Comcast disagrees with the results. The committee will hold a workshop on franchise issues in May. Comcast has agreed to take commercials off the community access channel (Ch. 26). With regard to the FM elimination, ongoing meetings with Comcast and representatives of FM stations are being conducted in an effort to restore this service.
- c. Golden Gate Bridge Highway & Transportation District Al Boro reported that MTC has approved \$1.6 million grant to the Bridge district for a suicide barrier, and additional funding is being solicited. A hearing on fare increases of 5-35 cents per ride on buses will be held in early May. The Bridge District reported that for the first time Fast Trak exceeded cash revenue on the bridge in March.
